Animal General Adoption Contract

In order to ensure the best homes for Animal General's animals, all adopters must read through, understand, and agree to abide by all the following policies and procedures.

Adopter Information

- You, the Adopter, will live with the animal in a place that permits the type of/number of animals you are adopting.
- You have permission from all family members or roommates to adopt the animal, and all members of the household agree to abide by the policies set forth by Animal General.
- You have never been subject to legal action for cruelty to or neglect of animals. You further confirm that you have never owned an animal that has been confiscated by animal control or a humane organization for violations of state or local regulations or laws.

Home Care

- You, the Adopter, will provide the animal with a permanent home for life. You will not abandon the animal or allow it to be used for research, scientific, or experimental purposes. In the event you are unable to keep the animal, you will make every effort to find it a loving home or you will surrender the animal to Animal General.
- You will provide the animal with fresh water, wholesome food, clean living conditions, adequate exercise, and affection daily. The animal will be treated as a companion and family member.
- You agree to have the animal registered/licensed in your city, if applicable. We require that all animals are microchipped and registered before leaving Animal General. This service is provided by Animal General prior to adoption and the registration fee is included in the adoption fee. After the animal leaves our facility, it will be your responsibility to keep your contact information updated with the microchip service. If the animal should become lost, you will make every effort to find the animal including notifying local shelters, animal control, police, and veterinarians.
- You promise never to declaw this cat. You agree that declawing consists of amputating not just the claws, but the phalanx, up to the joint, including bones, ligaments, and tendons. Declawing is not a simple surgery, but 10 separate painful amputations of the third phalanx up to the last joint of each toe. You agree declawing can cause serious physical, psychological, and behavioral complications. You understand that scratching is normal cat behavior and you will provide scratching pads and keep your cat's nails trimmed.

Veterinary Care

- You, the Adopter, agree to provide the proper veterinary care for the lifetime of the animal.
- You will provide prompt veterinary care to the animal if illness or injury should occur, and you will keep all the animal's vaccinations current including rabies and DHLPP vaccines for dogs, and rabies and FVRCP vaccines for cats.
- You agree that the animal will be spayed/neutered. This service is provided by Animal General on all animals prior to adoption unless it is unsafe due to age or medical condition, in which case an appointment will be scheduled at the time of adoption for you to bring the animal to our clinic. A deposit of \$50 is required, in addition to the \$100

adoption fee, if an animal leaves the hospital unaltered, which will be credited to your account towards of the cost of the future spay/neuter.

- For 30 days from the day you take your new pet home, their veterinary care is covered at Animal General for routine care such as booster vaccination appointments, diarrhea, or other non-surgical illnesses, such as upper respiratory infections, that may arise. This does not include a kitten's spay or neuter. When you adopt a senior cat (11 years and older) from Animal General, you receive a \$500 credit on your Animal General account towards your pet's future veterinary care. This offer is void for sickness or injury due to the owner's negligence or abuse.

Animal General's Rights

- You, the Adopter, will permit a representative of Animal General to do follow-up phone calls, e-mails, or home visits after the adoption.
- You understand that there are no refunds of the adoption fee.
- You understand that while Animal General does everything possible to assess the physical and mental condition of an animal, it was either surrendered or a stray, and Animal General cannot offer any guarantee or warranty of any kind on the health, age, temperament, mental disposition, or personality of the animal.
- You agree to release and hold harmless Animal General and its owner, administrator, doctors, staff, volunteers, and members from any and all liability or responsibility in connection with the animal. Furthermore, you release Animal General from any and all liability for damage or injury hereafter caused by the animal.

Animal Uncertainties the Adopter must be Aware Of

- Animal reactions to various stimuli such as human actions and other animals are often unpredictable and should be observed carefully.
- An animal's behavior may change after it leaves the hospital and accustoms itself to a new environment.
- Animals need to be introduced into homes with other animals cautiously, with the method based on the temperament of all of the animals. You should consult with your veterinarian on the appropriate way to introduce your new animal into your multi-animal home for proper adjustment and the lowest risk of incident.
- Puppies and kittens require extra training, medical care, and attention. Make sure you have enough free time and the finances available before adopting a puppy or kitten.
